OFFICIAL RULES

Eligibility: Road Ranger, L.L.C.’s Sweepstakes (“Sweepstakes”) is only open to legal residents of Illinois, Kentucky, Ohio, Indiana, Iowa, Wisconsin or Missouri, who are 18 years of age or older at time of entry.
